Safe-Guarding Policy



All adults working on behalf of children have a responsibility to protect them and to provide a safe environment in which they can learn and achieve their full potential. Everyone who comes into contact with children and their families therefore has a role to play in safeguarding children. SEND@Heart recognises that many of the children and families we directly support may be at greater risk of harm than typical students within mainstream schools and organisations. This is because we primarily work with young people who may for example:

- Have Education Health and Care Plans (EHCPs)
- Be in care, have a child in need plan or child protection plan
- Be out of school or a school refuser
- Have complex needs e.g. learning disabilities, non-verbal, social emotional or mental health needs, or physical disabilities
- Have otherwise known barriers to learning and inclusion.

Such factors make it more difficult for children/young people to express when something troubling has happened to them. SEND@Heart is committed to safeguarding and promoting the welfare of all children and vulnerable people who engage with our resources and services.

Ensuring that children with SEN and disabilities are fully supported, respected and heard is at the core of our mission.

We take our responsibility to create a safe and secure online environment, seriously. To ensure the safety and well-being of children on our site we review user-generated content to ensure it is appropriate for all audiences, particularly children and vulnerable individuals. Any content that violates our standards will be removed, and users may be banned from the site. We encourage parents and guardians to supervise their children's use of the site and to review any materials before they are accessed.
